Privacy Policy

United Foreclosure Relief ("UFR," "we," "us," or "our") operates the website freshstart.unitedforeclosurerelief.com. This Privacy Policy explains what information we collect, how we use it, and your rights regarding that information.

Information We Collect

When you submit a form on our website, we collect the following information: your name, email address, phone number, and full property address. We also collect your responses to whether you are currently in foreclosure and whether you have received a Notice of Default or Notice of Sale. If you become a client and sign a service agreement, we may additionally collect: your loan number, lender or servicer name, last four digits of your Social Security number, and your signature. We may also record phone calls and video meetings with your consent for compliance, quality assurance, and documentation purposes.

How We Use Your Information

We use the information we collect to respond to your inquiry and contact you about our services. With your written authorization, we may communicate with your lender, servicer, trustee, or other parties involved in your mortgage or foreclosure matter. We also use your information to coordinate with licensed real estate agents, title companies, and escrow officers in connection with the listing and sale of your property, and to maintain records for compliance and quality assurance.

How We Store Your Information

Information submitted through our website is stored in our customer relationship management (CRM) system. We use reasonable measures to protect your personal information from unauthorized access, use, or disclosure.

Information We Share

We do not share or sell your personal information. We may share your information with the following parties, only as necessary to provide our services and only with your written authorization: your mortgage lender or servicer, foreclosure trustees, licensed real estate agents or brokers, title companies and escrow or settlement agents, and attorneys involved in your matter.

Cookies and Tracking

Our website may use cookies and similar tracking technologies provided by third-party services such as Google Analytics to understand how visitors use our site. These tools may collect information such as your IP address, browser type, pages visited, and time spent on the site. You can control cookies through your browser settings.
